Behavioral finance studies confirm if Rafael won. Minimization does not rely only on instincts, like long-term memories but solid research to make solid decisions. Rafael secured better by considering his options correctly and assessing risk. Long-term behavior wins ultimately. By admitting to your flaws, strength is shown. In a sector rife with pride, that's an ability that is uncommon. This allows some people to ignore their intuition and control their emotions in the relatively straightforward game of wagers.
